The Minnesota Association of Dance Team (MADT) Hall of Fame is made up of past and current Minnesota dance team coaches. These individuals have demonstrated their passion for the sport of dance by making significant contributions to MADT, their athletes, their schools, and MN dance. The MADT Hall of Fame Committee will review all applications and nominations.

## Conditions for induction are:

- Nominees must exemplify the highest standards of sportsmanship, ethical conduct and moral character.
- The candidate must be a current or past MADT member. A nomination can be for someone that is deceased. The candidate must have held a Head Coaching position.
- The candidate must have made contributions to MADT. This is not limited to serving on the Board of Directors.
- The candidate demonstrates key coaching skills and decisions during the off-season and competitive season.
- All candidates will be judged on their significant contributions to MADT and Dance Team in Minnesota.
- While many have served their state and local programs over a long and distinguished career, a candidate's accomplishments must have been worthy of state recognition for them to be considered. Longevity, without meaningful state impact, does not constitute appropriate credentials for Hall of Fame consideration.

The award is presented at the MADT Spring Awards Celebration.
